VENEZUELA

LEY DE DIVERSIDAD BIOLOGICA

Artículo 73.- Todo procedimiento de acceso a los recursos genéticos requerirá de la aprobación de una solicitud, presentada ante la Oficina Nacional de Diversidad Biológica, de la suscripción de un contrato, de la publicación de la correspondiente resolución y el registro declarativo de los actos vinculados con dicho acceso.

Artículo 74.- Las solicitudes y contratos de acceso deberán contener:

4. La participación de los investigadores nacionales en las actividades sobre **recursos genéticos, sus componentes derivados** y del componente intangible asociado.
